OFFICIAL RULES

WHO IS ELIGIBLE:

Drawing is open to all U.S. Citizens who are 18 years or older and legal residents of the United States except Puerto Rico and other US territories. Entries are not valid for First Harvest Credit Union (First Harvest) employees, or a family member of an employee, First Harvest Investment Solutions, Supervisory Committee, or Board of Directors. HOW TO ENTER:

Automatic entries: Enroll all eligible First Harvest accounts for eStatements via Online Banking between April 1, 2026 and June 30, 2026. Log in to Online Banking, select your main membership Savings account, click Online Statements, go to the Edit User Settings tab and select "User Settings", select "Electronic" for all listed accounts, and click "Submit" to complete your enrollment. Qualifying enrollments are First Harvest membership accounts that switch from paper statements to eStatements between April 1, 2026 and June 30, 2026 by a First Harvest member in good standing. One automatic entry provided per membership account.

Alternate entry method: Other eligible individuals interested in participating in the drawing may enter by submitting a written request with your name, email, address, city, state, ZIP code, and telephone number in type or print to First Harvest Credit Union, c/o the Marketing Department, 1617 Hurffville Road, Deptford, NJ 08012 via U.S. Mail. One (1) mailed-in entry per person allowed. All U.S. Postal entries must be postmarked between April 1, 2026 and June 30, 2026 11:59:59 PM EST and received at First Harvest by July 14 2026 11:59:59 PM EST. First Harvest is not responsible for late, lost, illegible, incomplete, misdirected, misrouted, or inaccurate entries and such entries will be voided.

DRAWING, PRIZE, & PRIZE REDEMPTION:

First Harvest, whose decision is final, will randomly select one (1) winning entry from all eligible entries to receive one (1) \$500 First Harvest Account Credit. The winner will be notified on or around July 30, 2026 by email or telephone. If the winner cannot be contacted or does not respond in 14 days, the winner will be disqualified and a substitute winner will be randomly selected from the remaining entries.
